RENTAL REGULATIONS & EXPECTATIONS

Camp Menesetung is an accredited camp with the United Church of Canada and Ontario Camping Association. As such, we must adhere to very specific guidelines, and we ask that you also respect our Rental Regulations and Expectations.

1. All Groups using the Camp Property are reminded that the purpose of Camp Menesetung is to promote Christian values through education and fellowship.
2. All Groups using the Camp Property must provide proof of Liability Insurance coverage.
3. All vehicles must be left in the parking lot or along the roadway. Please do not drive on the grass and allow room for passage of emergency vehicles.
4. The natural beauty of the Camp property must be protected, and left in a clean and sanitary condition. We worked hard to prepare the site for your visit. Damage to the Camp Property and / or clean-up charges will be added to your bill.
5. Food in the Dining Hall has been purchased for Camp Menesetung program use only. If you use it the cost will be added to your bill.
6. If the camp is providing your meals, prior to your arrival all meal times must be scheduled in consultation with the cook. (No meals will be served after 8 P.M.)
7. No food is allowed in the cabins.
8. No food is to be left outdoors.
9. You must keep an accurate count of your participants for billing purposes.
10. The Garbage Policy is posted in every building. Please abide by it.
11. A telephone is located in the Dining Hall Building. It is available for emergency use only. Please do not answer it during camping season.
12. No Smoking is allowed on site or in any of the buildings on the Camp Property.
13. Campfires are permitted only in the designated areas. All fires must be properly extinguished before being abandoned.
14. Obey all federal and provincial laws while on site.
15. No Firearms or Explosives of any kind, including fire crackers, are permitted on the Camp Property.
16. The consumption of alcoholic beverages, cannabis, and illicit drugs on the premises is strictly prohibited.
17. Camp Menesetung is 'nut aware'. All groups are requested NOT to bring nut products on site for the benefit of our visitors who have severe allergies.
18. No Speeding through the Camp Property with motorized vehicles is permitted.
19. You are requested NOT to bring pets, unless with special permission of the Director. Animals (wild and domestic) are not allowed in the buildings. Dogs must be leashed at all times while on the Property. Proof of rabies vaccination is required.

20. The following boundaries have been set for all groups:
- The Front Gate & 30 feet behind the Cabins into the bush.
 - The Camp-side of the Ravine. (The Ravine itself is off limits)
 - Cottager's Road. (Outings to the Beach, i.e. walking down the Cottage Road, are allowed under proper supervision). The Cottager's Road is the only authorized route to the beach.
23. All Groups must have a minimum of one adult supervisor for every 10 participants under 18 years of age.
24. You are assuming all responsibility for the use of the pool with properly qualified lifeguards, including the actions of those in and around it, even when not in use.
25. Lifeguards at the pool must be a minimum of 18 years of age, and hold a current National Lifeguard Services Certificate. There must be 2 lifeguards on duty when the pool is being used. If you bring your own lifeguards they must provide photocopies of their qualifications upon arrival. Failure to do so will result in not being able to use the pool.
26. Camp Menesetung assumes no liability for off-site activities.
27. There must be a person with a minimum of Standard First Aid CPR-C Certificate on site at all times for the duration of your Camp.
28. Camp Menesetung is fully released from all health care responsibilities for the duration of your visit.
29. Before leaving the Camp, all items must be returned to their original position.
30. Before leaving the camp fill out and sign the Kitchen Checklist (if you prepared your own meals) and the Cabin and Building Checklist. Leave them on the counter in the kitchen if no Camp Menesetung personnel are present.
31. It is expected that all rental groups return the site to the state they found it in before departure or risk forfeiting their damage/cleaning deposit. Brooms and cleaning supplies will be made readily available.
31. Any Camp Menesetung designated representative has the authority to enforce these regulations, and, if necessary, to evict any person(s) behaving in a manner which is inappropriate to a United Church Camp.

By signing this Rental Regulations form, you acknowledge having read it, understood each of the sections and agree to fulfill the requirements listed above. Please ensure everyone in your group knows and understands these Camp Regulations.

I wish to reserve, on behalf of the above Group, the accommodations and facilities listed at the rate quoted. I also agree to ensure total payment of our account. I have also read the regulations, and agree to abide by them.
